## **DPAC**—Disabled People Against Cuts

A representative of Disabled
People Against Cuts
(DPAC) will be speaking at
the March Forum.

They say the following about themselves, voicing many of the concerns about perceptions of disabled people in society voiced in our own Language Code.

"DPAC was formed by a group of disabled people after the first mass protest against the austerity cuts and their impact on disabled people held on the 3rd October in Birmingham.

It was led by disabled people under the name of The Disabled People's Protest.

DPAC is for everyone who believes that disabled people should have full human rights and equality.

It is for everyone who refuses to stay silent about the injustices delivered by wealthy politicians on ordinary people and their lives.

The austerity measures however need to be seen in a wider historical context.

"Disabled people are an easy target because society has accepted the view that generally speaking disabled people are unable to



fully participate within society due solely to our impairments. This view, supported through negative and pejorative stereotyping, distorts who we are and the causes of the disabling barriers we face."

"Inappropriate and misleading labels such as "the disabled" or "vulnerable adults or children" reinforce prejudices and discrimination.

Disabled people are not "the disabled" – we are a diverse social group of people with a variety of impairments who continue to face unequal and differential treatment resulting from systems, structures and cultures which fail to take disabled people into account..."

#### **Equalities Consultation**

On 22<sup>nd</sup> February a consultation took place on Hackney Council's Equalities Strategy.

The 2010 Equality Act requires the Council to produce a strategy in line with the new public duty to promote equalities. This law bans unfair treatment and helps achieve equal opportunities in the workplace and in wider society.

The law provides that it is illegal to treat people unfairly because they have one or more of nine characteristics. The areas are age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex and sexual orientation.

Maureen Ford, who represented DBU at the meeting said: "Although the gap between rich and poor is getting greater, this is an effort to ensure that people do not suffer more because they are disabled or in another vulnerable group."

At a follow up meeting with Hackney's Equalities team it was agreed that the DBU language code – signed last year by the Speaker of Hackney – would be posted on the Council's website and that reference to it would be promoted.

#### **Update from February Forum**

At the February Forum, Michael from Graeae Theatre Company spoke to our members about the theatre company and showed a short clip about their latest production 'Reasons to be Cheerful'. The production is a part gig, part play creation which was well received in 2010.

Members were very interested and wanted to know more about when the play starts as well as the cost of tickets.

Two tickets were raffled by Michael from Graeae and DBU member Christiana Richardson was the lucky winner.

'Reasons to be Cheerful' runs only for a short period Wednesday March 28<sup>th</sup> to Sunday April 1<sup>st</sup>. Tickets are on sale at the Hackney Empire box office. Ticket prices start from £10.00 - £27.00 with a concession of £2.00 off.

All performances include captioned dialogue, BSL-interpreted songs and audio description.

#### **Victory for Crossings Campaign!**

DBU activists joined Living Streets and Transport for All (TfL) on February 15<sup>th</sup> in a rush hour roadside demonstration against Transport for London's plans to remove the pedestrian crossing on Curtain Rd. in Shoreditch.

The crossing, near Rivington St is used by people walking to the nearby Moorfields Eye



Hospital. Naturally, many of its users are visually impaired.

TfL wanted to remove the crossing to assist traffic flow. Now they say they will look again at the issue.

The Royal National Institute for the Blind (RNIB) has warned recently that 18 crossings in Hackney are dangerous for visually impaired people.

These crossings, which include ones in busy centres like Mare St and Kingsland Rd, lack the audible sounds and tactile rotating cones, which help visually impaired to cross the road safely.

#### **MOPC**

A DBU member recently attended a consultation meeting on the work of the Mayor's Office for Policing and Crime (MOPC).

MOPC replaces the Metropolitan Police Authority. The MOPC oversees the Metropolitan Police Service (MPS) and is responsible for ensuring that the MPS is efficient, effective and fair.

Andrea Rawlings commented: "This was an excellent opportunity to get into

discussions on policing strategy early on, as opposed to being consulted when everything has already been decided."

#### **Commissioning for Personalisation**

A wide ranging review is being carried out by Hackney Council of its services and how to make them more responsive to local people's needs – and save money.

A DBU representative is amongst other service user groups involved in discussions on the £1.7m currently spent by the Council on providing transport directly for journeys like those to day centres; residents' use of parks and libraries and a wide range of community based care, including provision for people with very high needs, including many disabled people.
