Meeting Housing Need

Deputy Mayor Cllr Karen Alcock will be attending our June Forum. She is Joint Chair of the Better Homes Partnership and leads for Hackney on a wide range of housing issues.

Lettings manager John Isted, is responsible for housing allocation for housing association and Hackney Homes properties

Liz Watson is the manager of the private sector housing team, which protects the rights of tenants with private landlords. Tenants can contact the team if they have a concern about conditions within their privately rented accommodation where the landlord has refused to take any action .

The team also addresses public health issues related to private sector housing such as rodents, insect infestations and dumping of rubbish. Their role is to make sure that landlords deal with public health problems. If you a resident living in Hackney with such concerns you can call the team on 020 8356 4556

Olympics

Three DBU representatives met Charlie Forman, the head of the Hackney 2012 unit, at the end of May, following his presentation at the April Forum, to discuss access arrangements for disabled people during the Olympic Flame procession on July 21st.

The Torch procession will enter Hackney on Shoreditch High Street at 3.47pm. It will travel north up Kingsland Road, left into Stoke Newington Church Street and right into Green Lanes and on into Clissold Park at 4.47pm.

We agreed there would be a platform for disabled people sited outside the police station on Stoke Newington High Rd., where the footway is particularly wide.

We also pressed for:

- Banning cycling in Clissold Park on the day, so that people with visual and hearing impairments are not at risk;
- Use of some of the electric vehicles available in the Olympic Park for the Clissold Park event;
- Details of the location of parking bays for disabled drivers;

We also expressed concern that the one entrance to be used to Clissold Park, on Green Lanes, would mean a long walk for disabled people.

On August 29th the Paralympic torch will travel from Stoke Mandeville to Victoria Park and then on to the Lido in London Fields.

Activities for that day are not yet finalised and the Hackney 2012 Olympic Team have said that they are open to suggestions as they are looking for ideas. So if you have any ideas, let us know and we will pass them on!

Health & Human Rights

DBU representatives attended a meeting of the British Institute for Human Rights' Health & Human Rights network on 15th June.

David Price, a Senior Research Fellow at the Centre for Primary Care and Public Health spoke about the human rights implications of the Health and Social Care Act and Stephen Bowen, Director of the BIHR, gave an overview.

The meeting went on to discuss various groups' plans to incorporate awareness of human rights into their work in the next year.

A free and fun 2012 event for disabled people

Firstly, apologies, the Fattylympics - a non-profit community event satirising the You Know Whats in East London 2012 - will take place on Saturday, 7th July at Grassroots, West Ham (and not in June as we incorrectly reported last month).

Between noon and 5pm the event, supported by Disabled People Against the Cuts, will have fun performances and DIY activities, but the focus will be on non-competitive games.

One of the organisers, Charlotte, said: "It's important we make the Fattylympics as accessible as we can. It's free to attend, held in a space that is accessible by public transport, with parking nearby, and flat surfaces and accessible loos for wheelies."

The event will take place at the Grassroots Resource Centre, Memorial Park, Memorial Avenue, West Ham, E15 3DB.

How to get there:

Public transport: West Ham Station is served by the Jubilee, District and Hammersmith and City underground lines. It is also accessible via the DLR and is on the c2c line which goes from Liverpool Street to Shoeburyness. The 276 and 323 buses stop close by.

Private transport:- There is free parking on the streets by Memorial Park, and behind the Grassroots building. There are secure bike racks, and buggy racks for people with children, right in front of Grassroots.

Academies Free to Ignore Protection for Disabled People?

Following press reports of the refusal of Mossbourne Academy to admit an 11 year old boy with cerebral palsy on the grounds that his attendance would 'adversely affect other students,' DBU has written to Education Minister Michael Gove.

Mossbourne says that because it is an Academy it is not subject to a 'special educational needs tribunal,' like other schools.

This means that it is impossible to test the school's argument and regulations laid down to protect disabled people can be ignored by a school because it has Academy status.

So DBU has asked Mr Gove to whether this is the case and if so how it can be justified.

We think that young people should not be excluded from learning opportunities because of impairments which are irrelevant to their academic potential.
