# **Chair of London Assembly Signs DBU Language Code**

A DBU delegation visited City Hall on October 25th to present the DBU Language Code to Jennette Arnold, Chair of the London Assembly, and to get her endorsement for it.

The Language Code (http://www.disabilitybackup.org.uk/language.php) promotes positive language about disabled people and is founded upon the social model of disability, which focuses attention on the social barriers that prevent full equality for disabled people.

Maureen, Henrietta, Sandra, Andrea and Akira went with Carol as part of a series of meetings with local public figures to get them to sign

the Code. Karen Alcock, the Deputy Mayor of Hackney and the Speaker of Hackney have also signed it.

Maureen said: "Signing the Language Code supports the use of positive language about disabled people in public services, which encourages us and others to go on raising awareness of the importance of using appropriate language." Jennette agreed and promised to circulate the Code to City Hall officers and to the human resources department.

The delegation also discussed issues raised by DBU's recent Transport Report. Akira, who is a wheelchair user,

was particularly concerned to underline the problems many of us have in using buses. Jennette suggested that we seek a meeting with Isabel Dedring, the Deputy Mayor with responsibility for transport issues.

Jennette commented on the positive work that DBU is doing and has promised to continue to lend her support and will visit our forum in January.

#### **November Forum**

The November forum will cover Welfare Benefits and Hate Crime.

The Government says that changes will make the lives of disabled people better. However, disabled people still have questions that they feel are not being answered. People who have long term conditions are very much at risk as a result of the cuts and are therefore at risk of poverty, debt and isolation. Lee Simpson the Partnership Support Manager from DWP East London will give members an update on benefits. Odette Messiah the Advice and Information Manager at Age UK will also talk on benefits from the perspective of providing guidance and support if people are not clear on where to get help or need help to maximise their benefits.

John McArdle is one of the founding members of Black Triangle which has a large supporter base of disabled people. John tirelessly campaigns for the rights of disabled people and raises awareness about hate crime.

John, who is disabled himself, knows all too well the problems that disabled people face on a day to day basis. Hate crimes can have disastrous effect on victims, resulting in depression, anxiety, stress and anger, leading to people becoming more and more isolated for fear of victimisation. Disabled people believe that cases of hate crime against disabled people need to take priority.

The Office for Public Management (OPM) research report on violence and hostility against disabled people found that hate crimes have powerful symbolic and concrete impacts that extend way beyond the physical and emotional harm experienced by the victims.

We have invited John McArdle from Black Triangle and PC Crane to come and talk to us about Hate Crime.

Attacks against disabled people have increased and despite the rise in crime levels the number of people convicted has fallen and many cases are not reported. The way that crime is reported and the views and perspective of police have a great impact on how cases are dealt with.

Police services believe that low prevalence figures are a result of under-reporting but do not generally accept that low prevalence figures were a result of non-identification and miscategorisation by police officers.

There has been some improvement as some police services are now recording hate incidents as well as hate crimes. PC Crane (Metropolitan Police) has been invited to come along and talk to members and inform them how hate crime is being addressing in Hackney.

# DBU Delegation Goes to Council Meeting

DBU members Akira, Andrea, John, and Ron went as a deputation to the Full Council meeting on October 24<sup>th</sup> to draw the attention of councillors to our recent report on the experience of disabled people in Hackney of access to transport. The delegation was sponsored by Cllr Sally Mulready, who is herself disabled.

This meant that at the beginning of the council meeting, we got five minutes to state our concerns, in this case on issues such as cycling on pavements and in parks, obstructive clutter on the footways like 'A' boards and the need for council staff to be trained in disability equality awareness – with the involvement of disabled people themselves. Then Members asked questions, which allowed the issue to be explained more fully and the cabinet member responsible for the area, Cllr Feryal Demirci, responded to the issues raised.

Despite there being two other delegations to this council meeting, we got a very friendly reception, with questions asked by Cllrs Luke Akehurst, Vince Stops, Saleem Siddiqui, Sharon Patrick, Linda Kelly and others. Issues such as buses failing to drop ramps, space on the new 38 buses and the need for an access audit in Hackney were raised.

Cllr Demirci, who spoke at the October DBU Forum, welcomed the delegation and talked about site visits to inspect obstacles, the £50K being spent on dropped kerbs this year — with the budget being doubled next year.

She said 95% of bus stops in Hackney would be accessible by the end of this financial year and promised a written response to the Report from Streetscene.

After the meeting, Cllr Mulready invited us to write to her as Chair of the Council's Regulatory Committee, asking for an annual audit of how successful enforcement was in the areas that concerned us. Cllr Kelly offered to arrange a meeting with the leader of the Conservative Group in the London Assembly, Andrew Boff AM, to discuss the concerns raised in the report as they affected the GLA – Labour Assembly Chair Jennette Arnold contributed an introduction to the Report.
