# What now for Hackney Disabled People?

Our March Forum will take place on March 25<sup>th</sup>. Cllr Jonathan McShane will be iattending. Jonathan is Cabinet Member for Health, Social Care and Culture in Hackney, which means that he is accountable for several areas such as sport and leisure, adult social services, supporting people, culture, parks, libraries, adult learning, the voluntary sector, volunteering and health.

Jonathan will talk to members about the future for disabled people in Hackney - including, including the legacy of the 2012 Olympics and how disabled people in Hackney will benefit.

We also have Stella Rafferty and her colleague Amanda Elliot from Hackney Council's User Development Team coming to the March Forum. Stella and Amanda would like to consult with members about two reports: The Local Account Report and Hackney Market Position Statement, which relate to service user satisfaction with Council services.

The outcome of these reports will feed into the production of two important Council documents about adult social care in Hackney with the ultimate aim of improving services.

All service user groups are being consulted and further information will be gathered from the Health & Community Services survey, which must be completed online.

#### **DBU** in the Next Year

In the coming year there will be changes in how frequently our Forum will be meeting, as we adjust to a much reduced level of funding for the coming year.

We have been successful in winning some funding in the competition for general grants from the Council for the voluntary sector – this is decided by an independent panel with all applications marked and with a voluntary sector representative involved.

However we have been awarded about half what we applied for, which means we will have less time for admin support and fewer resources for expenses like postage, printing, transport and venue hire.

This means it is likely that we will be holding a quarterly meeting of the Forum, with the next one in May. This does not mean we cannot continue to lobby for disabled people's interests or take up any area where our members are seeking information or change, from access to leisure and cultural opportunities or housing to transport.

But it will mean that in between Forums some members meet, as a planning group, perhaps sometimes as a business meeting and sometimes as an open meeting, the dates and times of which can be publicised in the quarterly newsletter.

Last month we informed you that we will be having an Adult Social Care event in March. The event has been postponed and rescheduled to take place on May 20th, when we will have the managers of Adult Social Care present to hear the outcome of the Adult Social Care Assessment.

Members are asked to complete the survey and return to us by May 10<sup>th</sup> allowing sufficient time for us to analyse the results of the survey before the meeting with managers to discuss the results. Some of you will be contacted over the telephone by a Comms Team member to see if you need assistance in completing the survey.

For Hackney's Market Position Statement the survey would like your views on:

• What types of services do disabled people, older people, carers and other service users in Hackney want?

• What do people like about the services they use already What services do you think are missing or could be improved.
