## Voting: your voice matters

DBU coordinator, Helen Wildbore, reports on important changes about how we register to vote, and on accessibility of polling stations.

Did you know the way we register to vote is changing? You will have received a letter through the post this summer telling you about changes to voter registration. Instead of the old 'head of household registration', each person will now have to register to vote individually.

Most people already registered to vote will transfer automatically to the new system but some people will need to provide extra information (such as your date of birth or National Insurance number).

Look out for your letter in the post, which will contain instructions about what to do. If you haven't received your letter, you can speak to the Electoral Registrations and Elections Office at the Hackney Council on 020 8356 3232.

Are polling stations in Hackney accessible? In the 2010 general election only a third of polling stations were accessible (according to a report by Scope called 'Polls Apart 2010'). 67% had one or more significant access barriers to disabled voters.

DBU would like to hear from you about voting in Hackney. Did you have any problems voting at the last election? Were polling

stations fully accessible with tactile voting devices, large print ballot papers, low level polling booths, level access into the polling



station? Give us your feedback so that we can raise any issues or problems before the general election next Spring.

Hackney Council is also conducting a review of locations of polling stations and asking for any suggestions for new premises. The deadline for submissions is 15 September, so let us know if you have any concerns you'd like us to raise. ## **Disability and Poverty**

Planning Team member Anthony Larvin reports on the APPDG meeting he attended.

I attended the All-Party Parliamentary Disability Group (APPDG) in the House of Lords in July. The APPDG works on an all-party basis within parliament "for the interests of all disabled people, their families and friends". This meeting was about Disability, Long Term Conditions and Poverty. It discussed a new report on 'Monitoring Poverty and Social Exclusion 2013' by the New Policy Institute, commissioned by the Joseph Rowntree Foundation.

The report found that most previous studies tend to underestimate levels of poverty among disabled people. Two of the authors of the report discussed the size of these underestimates, explored the difficulty in escaping poverty through paid work and how policymakers might tackle this.

The research found that families with a disabled member are more likely to be in poverty than other families, although the proportion in poverty has declined over the last decade. But the inclusion of particular disability benefits as income artificially lowers this poverty rate. When Disability Living Allowance and Attendance Allowance are not counted as 'income', the effect is to double the number of people counted as living in poverty who receive these benefits. The report also found that disabled people also face disadvantages in the labour market, with higher rates of worklessness and lower rates of pay than non-disabled people with the same level of qualifications (although the gap has been getting smaller).

At the meeting there was consent to explore the inadequate sick pay support system as it has been blurred with general employment in the past and it is unclear whether it is a disability or illness when analysed. To move forward the Department of Work and Pensions now has good data to support future discussions. The next APPGD will be in October.

#### Council tax discount

Did you know there is a discount on council tax for disabled people? The scheme makes sure you don't pay more Council Tax if you need a bigger property or to adapt your home.



If your property has an extra bathroom, kitchen or other room for a disabled person or extra space inside for using a wheelchair, then you can apply for your Council Tax Band to be reduced. Guidance and the application form are available on Hackney Council's Revenues and Benefits website, or by calling 0208 356 3154.
